5 **A BILL**

6 **For an ordinance amending Ordinance No. 1291, Series of 2021 concerning**
7 **the “Transportation and Mobility” Special Revenue Fund.**
8

9 **WHEREAS**, Ordinance No. 1291, Series of 2021, established the Transportation and
10 Mobility Special Revenue Fund No. 11882, increasing parking meter rates from \$1 to \$2 per hour
11 with the additional \$1 per hour dedicated to support transportation and mobility projects related to
12 bicycles, sidewalks, safety, and transit improvements; and

13 **WHEREAS**, at the end of 2021 the Denver County Court, through the Presiding Judge,
14 amended the Parking Citation Fine Schedule resulting in increased enforcement fines and
15 therefore revenue, effective February 1, 2022 for the purpose of supporting transportation and
16 mobility projects; and

17 **WHEREAS**, the Presiding Judge determined that Parking Citation Fine increases are
18 necessary to support the safety of the streets, curbside space, new modes of transportation, bus
19 lanes, delivery activities, pedestrians, and needs of adjacent land uses; and

20 **WHEREAS**, the City desires to dedicate the incremental revenue derived from the 2022
21 increase from said Fines to support alternative modes of transportation and mobility projects that
22 increase the safety of Denver’s transportation network;

24 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
25 **OF DENVER:**

26 **Section 1.** Section 1 of Ordinance No. 1291, Series of 2021, is hereby amended to read as
27 follows:
28

29 **“Section 1.** A new Fund is hereby established in the General
30 Government Special Revenue Fund Series, Accounting No. 11000, a
31 “Transportation and Mobility” Fund, Accounting No. 11882, for the purpose
32 of accounting for the receipt and expenditure of program dollars. That portion
33 of parking fine revenue attributable to the amended Parking Citation Fine

1 Schedule increase enacted by the Denver County Court effective February
2 1, 2022 shall be dedicated to this program and deposited to said fund to the
3 extent that said fine is collected by the City. That portion of parking meter
4 rate revenue attributable to the \$1 per hour increase enacted by the City
5 effective January 1, 2022 shall be dedicated to this program and deposited
6 to said fund.

7
8 **Section 2.** Section 2 of Ordinance No. 1291, Series of 2021, is hereby amended to read as
9 follows:

10 **Section 2.** Monies received from General Fund transfers, parking
11 meter revenue, and parking citation fines dedicated for Transportation and
12 Mobility Fund purposes, or other sources of income for Accounting No.
13 11882 shall be deposited into the Treasury of the City and credited to Special
14 Revenue Fund No. 11000, which is set forth and described in Section 20-18
15 of the Revised Municipal Code of the City and County of Denver.

16
17 **Section 3.** A new Section 4 is hereby added to Ordinance No. 1291, Series of 2021, to read as
18 follows:

19 **Section 4.** To ensure that the correct amount of revenue is dedicated
20 to this program, the amount appropriated each year shall be increased or
21 decreased by the difference between (1) the prior year's appropriation that
22 was based upon estimated revenues and (2) the actual revenues received
23 in the prior year as determined by the annual audit of the City's financial
24 statements, per fiscal year-end close.

25
26 **Section 4.** The prior Section 4 of Ordinance No. 1291, Series of 2021, is hereby amended to be a
27 renumbered Section 5, to read as follows:

28 **Section 4~~5~~.** The Chief Financial Officer of the City and County of
29 Denver is hereby authorized and directed to make such book and record
30 entries and to do such other things as may be necessary to accomplish the
31 purposes of this Ordinance.”
