4 **A RESOLUTION**

5 **To appoint Ana Varela to the Denver County Cultural Council.**

7 **WHEREAS**, Colorado Revised Statute 32-13-103(3) provides for the appointment of a county  
8 cultural council by the Denver City Council to provide for the distribution of Tier III revenues as  
9 required by the Denver Metropolitan Scientific and Cultural Facilities District; and

10 **WHEREAS**, the eleven-member Denver County Cultural Council has been established by the  
11 City Council to institute procedures for the application and determination of the distribution of Tier III  
12 funding; and

13 **WHEREAS**, the ordinance establishing the Denver County Cultural Council requires the  
14 appointment of eight members by the City Council for staggered terms of two, three, and four years  
15 and three members representing Denver Arts & Venues, Visit Denver, and Denver Public Schools,  
16 each for two-year terms.

18 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
19 **DENVER:**

21 **SECTION 1.** That the Council hereby appoints Ana Varela to the Denver County Cultural  
22 Council for a term effective immediately and ending October 1, 2028; or until a successor is duly  
23 appointed and is hereby approved.

24 **SECTION 2.** That the Clerk of the City and County of Denver shall attest and affix the seal of the  
25 City and County of Denver to this resolution and that copies hereof be transmitted to the Denver  
26 County Cultural Council.
