5 **A BILL**

6 **For an ordinance making a rescission from and an appropriation in the Parks,  
7 Legacy Fund; transferring cash to the Parks, Trails, and Open Space Capital  
8 Improvement Fund; and authorizing an appropriation in the Parks, Trails, and  
9 Open Space Capital Improvement Fund.**

11 **WHEREAS**, the City and County of Denver has signed a Purchase and Sale Agreement for  
12 4987 North Grant Street in Northwest Denver Globeville neighborhood to provide additional  
13 accessibility to Platte Farm Open Space; and

14 **WHEREAS**, additional appropriation is required in the Parks Legacy Improvement Projects  
15 Fund, Fund No. 36050, to support the property acquisition; and

16 **WHEREAS**, funds are available for this acquisition in the Parks Legacy Fund, Fund No.  
17 15828, and such uses are allowable per the Denver Revised Municipal Code through authorized  
18 transfers to a capital project fund; and

19 **WHEREAS**, Fund No. 15828 was originally called the "Parks, Trails, and Open Space"  
20 Special Revenue Fund but was changed to the "Parks Legacy" Special Revenue Fund through  
21 Ordinance No. 1295, Series of 2021; and

22 **WHEREAS**, the names for capital project funds for this program were also changed to  
23 reflect "Parks Legacy" through Ordinance No. 1295, Series of 2021; and

24 **WHEREAS**, Fund Series 36000 is still identified in the Denver Revised Municipal Code as  
25 the Parks, Trails and Open Space Capital Improvement Fund; however, the City intends to change  
26 this to also reflect "Parks Legacy" through a forthcoming Ordinance;

28 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY  
29 OF DENVER:**

31 **Section 1.** From appropriations heretofore made from the Parks Legacy Special Revenue Fund  
32 listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or  
33 indicated in such tabulation under the heading "Amount Rescinded":
