EXECUTIVE SUMMARY

Contract with Law Offices of Frank Moya

The Court is required by law to provide representation to indigent defendants facing the possibility of a jail sentence. In August the Court issued a Request for Proposal for legal services for indigent individuals charged with offenses of the Denver Revised Municipal Code. Two proposals were received and the proposal from the Law Offices of Frank Moya was selected. Mr. Moya's staff will provide legal representation to indigent defendants charged with municipal offenses in three trial courtrooms (3F, 3G, and 3H in the Lindsey-Flanigan Courthouse); homeless defendants; and defendants in the "Court to Community" program or its successor specialty court.

The contract amount for 2014 is \$525,000.
