6 **For an ordinance making a rescission from a completed Capital Improvement**
7 **Program, PO011, and making an appropriation in Capital Improvement Program,**
8 **HY002, to support the development of micro communities for individuals**
9 **experiencing homelessness.**

10 **WHEREAS**, the City wishes to rescind \$2,000,000 in savings from the completed Capital
11 Improvement Program, RAMP: Federal Boulevard (6th to Howard); and

12 **WHEREAS**, said savings will be appropriated to the Micro Communities Implementation
13 Capital Improvements Program to fund capital costs associated with the implementation of new
14 micro communities in the City, including design and site work for new tiny home communities in the
15 City and County of Denver;
