This contract amendment will increase the maximum contract value for Hensel Phelps Construction to complete projects that support and maintain the continuity of services for the operation of the Central Utility Plant and HVAC systems throughout the Airport facility. Increased contract capacity enables DEN to complete the Capital Improvement Projects (CIPs) over the next 18 months. It also supports the current emergency repairs needed for three (3) of the eight (8) boilers, resulting from a failure within the boiler units on November 30, 2025.

Completion of these projects directly supports DEN's Vision 100 strategic pillar, "Maintaining What We Have," to enable effective lifecycle management, reduce asset downtime and upgrades, and improve the existing legacy infrastructure within the facility.
