Scope of Board/Commission:

The Denver Immigrant and Refugee Commission (DIRC) advocates for the immigrant and refugee communities of the City of Denver. They connect communities with allies, stakeholders and resources in Denver; providing valuable community context and input to policy makers. The Commission engages communities in an integrative and meaningful way, providing education by raising awareness about resources that will make their integration into the Denver community easier. The role of the commission is to develop collaboration and partnership between Denver’s immigrant and refugee communities and the City & County of Denver.

Appointment Process:

The Mayor appoints up to 21 members and City Council confirms appointments for a term of 3 years.
