5 **A BILL**

6 **For an ordinance establishing a new fund in the General Government Special**
7 **Revenue Fund Series for the “2020 Census Fund”.**

9 **WHEREAS**, the United States Census Bureau conducts a count of the United States
10 population every ten years; and

11 **WHEREAS**, the City and County of Denver wishes to invest city resources to produce a full
12 and accurate count of Denver’s population in the 2020 Census; and

13 **WHEREAS**, the 2019 Annual Appropriating Ordinance includes a General Fund transfer in
14 the amount of \$400,000 to the “General Government SRF” to support outreach related to the 2020
15 Census;

17 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
18 **OF DENVER:**

20 **Section 1.** A new fund is hereby established in the General Government Special Revenue Fund
21 Series, Accounting No. 11000, a “2020 Census Fund”, Accounting No. 11869, for the purpose of
22 accounting for the receipt and expenditure of Census program dollars.

23 **Section 2.** Monies received from transfers from other City funds, donations, and other sources
24 of revenue for Accounting No. 11869 shall be deposited into the Treasury of the City and credited to
25 Special Revenue Fund No. 11000, which is set forth and described in Section 20-18 of the Revised
26 Municipal Code of the City and County of Denver.

27 **Section 3.** Program expenditures are hereby authorized for the “2020 Census Fund”,
28 Accounting No. 11869, in the amount not to exceed the total of deposits described in Section 2 of
29 this ordinance expended by the Director of Human Rights and Community Partnerships. Authorized
30 expenditures for Accounting No. 11869 include but are not limited to the cost of outreach,
31 engagement, and marketing efforts to conduct a full and accurate count of the population of the City
32 and County of Denver in the 2020 Census. This is a cash basis, non-lapsing fund.

1 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized
2 and directed to make such book and record entries and to do such other things as may be necessary
3 to accomplish the purposes of this Ordinance.
