For the past decade, Yoga on the Rocks and the Five Points Jazz Festival have become tenured events. For the past several years Colorado Threads has been a partner of Yoga on the Rocks and sold yoga themed merchandise at the events. Colorado Threads and DAV have agreed to split the revenue (profits) of these sales at a 60% to Colorado Threads and 40% to DAV.
