8 **For an ordinance making supplemental appropriations to the Denver  
9 Municipal Airport System Enterprise Capital Equipment and Improvement  
10 Fund.**

12 **WHEREAS**, the Airport’s unrestricted cash balance has been steadily increasing  
13 over the past few years; and

14 **WHEREAS**, the Airport is requesting additional capital appropriation to utilize cash  
15 reserves to fund near-term capital projects instead of issuing debt to fund such projects;

16 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND  
17 COUNTY OF DENVER:**

18 **Section 1.** From the Denver Municipal Airport System Enterprise Fund, Accounting No.  
19 73000, out of monies not otherwise appropriated and in addition to amounts heretofore  
20 appropriated by Ordinance No. 1032, Series of 2016, and any supplemental appropriations or  
21 rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the  
22 amount of money following such designation, to be expended for the purposes and upon the  
23 authorizations in said Ordinance set forth:

29 or equipping airport facilities.




1       **Section 2.** The Chief Financial Officer of the City and County of Denver is hereby authorized
