Denver International Airport (DEN) uses millwrights to move, assemble, install or dismantle machinery, in particular the baggage handling systems and the jet bridges. Task may include demolition of existing baggage and demand control ventilation (DCV) equipment, installation of new baggage equipment, and fabrication and installation of system materials such as catwalks and ladders. Associated electrical work may also be required. The work included in these tasks will only be for existing structures. The contract amount was established by reviewing the projects expected to be completed on the Capital Improvements List over the next three years. The last round of On-Call Millwrights contracts expired in 2019 and demand is needed for work on Jet Bridges and AGTS projects.
