SECOND AMENDATORY AGREEMENT

This SECOND AMENDATORY AGREEMENT is made between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "City") and ENVIRONMENTAL HAZMAT SERVICES, INC., a Colorado corporation with its principal place of business located at 4086 Youngfield Street, Wheat Ridge, Colorado, 80033 (the "Contractor"), jointly ("the Parties").

RECITALS:

A. The Parties entered into an Agreement dated July 17, 2018 and First Amendatory Agreement dated April 29, 2021 (collectively, the "Agreement") to perform, and complete all of the services and produce all the deliverables set forth on Exhibit A, Scope of Services, to the City's satisfaction.

B. The Parties wish to amend the Agreement to extend the term, rescind section 24 "No Employment Of Illegal Aliens To Perform Work Under The Agreement", and modify section 27 "No Discrimination In Employment".

NOW THEREFORE, in consideration of the premises and the Parties' mutual covenants and obligations, the Parties agree as follows:

1. Section 3 of the Agreement entitled "<u>**TERM**</u>" is hereby deleted in its entirety and replaced with:

"3. <u>TERM</u>: The term of the Agreement will commence on July 17, 2018 and will expire on January 12, 2024 (the "Term")."

2. Section 24 of the Agreement entitled "<u>NO EMPLOYMENT OF</u> <u>ILLEGAL ALIENS TO PERFORM WORK UNDER THE AGREEMENT</u>" is herby deleted in its entirety and replaced with:

"24. RESCINDED"

3. Section 27 of the Agreement entitled "<u>NO DISCIMINATION IN</u> <u>EMPLOYMENT</u>" is hereby deleted in its entirety and replaced with:

"27. <u>NO DISCRIMINATION IN EMPLOYMENT</u>: In connection with the performance of work under the Agreement, the Contractor may not refuse to hire, discharge, promote, demote, or discriminate in matters of compensation against any person otherwise qualified, solely because of race, color, religion, national origin, ethnicity, citizenship, immigration status, gender, age, sexual orientation, gender identity, gender expression, marital status, source of income, military status, protective hairstyle, or disability. The Contractor shall insert the foregoing provision in all subcontracts."

4. As herein amended, the Agreement is affirmed and ratified in each and every particular.

5. This Second Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
