5 **Accepting and approving the plat of Loretto Heights Filing No. 2.**

6 **WHEREAS**, the property owner of the following described land, territory or real property situate,
7 lying and being in the City and County of Denver, State of Colorado, to wit:

8 LOT 2, BLOCK 1, AND TRACT D, LORETTO HEIGHTS FILING NO. 1, ACCORDING TO THE
9 PLAT THEREOF RECORDED SEPTEMBER 21, 2021, AT RECEPTION NO. 2021179359, CITY
10 AND COUNTY OF DENVER, STATE OF COLORADO.

11 CONTAINING 77,012 SQUARE FEET OR 1.77 ACRES, MORE OR LESS

12 propose to lay out, plat and subdivide said land, territory or real property into lots, blocks, and tracts
13 and have submitted to the Council of the City and County of Denver a plat of such proposed
14 subdivision under the name and style aforesaid, showing the adjacent streets and platted territory,
15 accompanied by a certificate of title from the attorney for the City and County of Denver; and
16 dedicating the easements as shown thereon; and

18 **WHEREAS**, said subdivision was surveyed by or under the direction of the City Engineer of the
19 City and County of Denver and said City Engineer has certified as to the accuracy of said survey and
20 said plat or map and their conformity with the requirements of Chapter 49, Article III of the Revised
21 Municipal Code of the City and County of Denver, and said plat has been approved by the City
22 Engineer, the Executive Director of Community Planning and Development, the Executive Director of
23 the Department of Transportation and Infrastructure and the Executive Director of Parks and
24 Recreation;

25 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**


26 **Section 1.** That the Council hereby finds and determines that said land, territory, or real
