Accepts and appropriates \$195,000 from a Colorado Historical Society grant for the rehabilitation of the Cheesman Park Pavilion. The Committee approved filing

this bill by consent on 5-7-10.

CB10-0355 A bill for an ordinance approving a proposed Tenth Amendment to Agreement between General Services Administration and the City and County of Denver/Denver International Airport related to leased space at Denver International Airport. (ECONOMIC DEVELOPMENT)

Adds 2,166 square feet of space in Concourse A to the General Services Administration's lease for a Transportation Security Administration (TSA) command center for additional rent of \$181,000 annually. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The bill was approved for filing by consent on 5-6-10.

CB10-0337 A bill for an ordinance approving a proposed Support Facilities Lease Agreement between the City and County of Denver and Texasworld Service Co. Inc. dba World Service Company, related to leased space at Denver International Airport. (ECONOMIC DEVELOPMENT)

Approves a lease of a small office of 141.1 square feet on the ramp level of Concourse A to World Service Company for contracted cleaning services for several airlines at DIA. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The Committee approved filing this bill on consent 4-30-10.

CB10-0356 A bill for an ordinance approving a proposed Support Facilities Lease Agreement between the City and County of Denver and Worldwide Flight Services, Inc., related to leased space at Denver International Airport. (ECONOMIC DEVELOPMENT)

Approves a month to month leases a small office of 141.1 square feet on the ramp level of Concourse A to Worldwide Flight Services for its contracted ground handling services for several airlines at DIA. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The bill was approved for filing by consent on 5-6-10.

CB10-0357 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Woolpert, Inc. concerning A-GIS at Denver International Airport.. (ECONOMIC DEVELOPMENT)

Approves an agreement with Woolpert, Inc to develop an electronic Airport Layout Plan (eALP)/ Airport-wide Geographic Information System (that meets FAA requirements. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The bill was approved for filing on consent on 5-6-10.

CB10-0413 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Randall Funding & Development, Inc., to extend the term and provide additional compensation for the provision of general grant writing services. (FINANCE)

Approves a one-year extension to the Randall Funding and Development grant writing contract. The contract amount is \$10,000 per month and will bonus

\$50,000 if the City is successful in getting \$5 million and \$10 million in grant approvals. The maximum pay out is \$220,000 per year. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The Committee approved filing this bill by consent on 1-1-10.

CB10-0340 A bill for an ordinance to amend Chapter 32 to adjust occupational privilege tax registration fees. (FINANCE)

Amends the Occupational Privilege Tax (OPT) registration fee as provided in Section 32-107 in the Denver Revised Municipal Code to create a tiered biennial structure. For businesses that owe less than \$30 in combined employee and business OPT in the 12 months prior to the registration year will not incur a fee. A \$25 fee will be imposed for individuals, sole proprietors and partnerships with no employees subject to the OPT and that pay in advance the OPT fee. A \$50 fee will be imposed for all other businesses. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The Committee approved filing this bill at its meeting on 5-5-10.

CB10-0331 A bill for an ordinance authorizing the issuance of City and County of Denver, Colorado, Tax-Exempt General Obligation Better Denver Bonds, Series 2010A, the City and County of Denver, Colorado, Taxable General Obligation Better Denver Bonds (Direct Pay Build America Bonds), Series 2010B, and the Tax-Exempt General Obligation Refunding Bonds, Series 2010C, for the purpose of financing and/or refinancing and defraying the cost of acquiring, constructing, installing and improving various civic facilities, together with all necessary, incidental or appurtenant properties, facilities, equipment and costs, and refunding a portion of the City's outstanding general obligation bonds; providing for the levy of general ad valorem taxes to pay the principal of and interest on the Bonds; authorizing the execution of certain agreements and providing other details in connection therewith; ratifying action previously taken relating thereto; providing other matters relating thereto; and making other provisions relating thereto. (FINANCE)

Authorizes the Manager of Finance to issue up to \$375,000,000 of City and County of Denver, General Obligation Bonds, Series 2010A-B and up to \$300,000,000 City and County of Denver, General Obligation Refunding Bonds Series 2010C. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The Committee approved filing this bill at its meeting on 5-5-10.

CB10-0348 A bill for an Ordinance approving a payment to Insight Public Sector, Inc. as Oracle's reseller for database maintenance. (FINANCE)

Approves payment to Insight as Oracle's reseller for database software maintenance covering the period of August 30, 2010 – August 29, 2011 in the amount of \$506,994.89. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The Committee approved filing this bill by consent on 5-6-10.

CB10-0345 A bill for an Ordinance creating Section 20-76(e) of Division 3 of Article IV of Chapter 20, Treatment of Employees Associated with City

Contracts, concerning prevailing wage penalties. (FINANCE)

Amends Chapter 20, Section 20-76(e) of the Revised Municipal Code authorizing the Auditor to assess penalties against contractors paying workers less than prevailing wages. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The Committee approved filing this bill at its meeting on 5-5-10.

CB10-0350 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and Lutheran Family Services concerning the "Unaccompanied Refugee Minors" program and the funding therefor. (NEIGHBORHOOD, COMMUNITY & BUSINESS REVITALIZATION)

Authorizes acceptance of \$86,004.57 from Lutheran Family Services of Colorado to the Department of Human Services to provide appropriate skills for unaccompanied minor refugees to enter adulthood and to achieve social self-sufficiency. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The Committee approved filing this bill by consent on 5-7-10.

CB10-0415 A bill for an ordinance authorizing the Mayor and other proper officials to enter into a contractual agreement with the State of Colorado for a "Community Services Block Grant FY10-11" program and the funding therefor. (NEIGHBORHOOD, COMMUNITY & BUSINESS REVITALIZATION)

Authorizes a grant agreement and appropriation in the amount of \$1,058,194 with the Colorado Department of Local Affairs for the Community Services Block Grant for the FY 2010-2011 program year beginning March 1, 2010. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10.0. The Committee approved filing this bill by consent on 3-19-10.

CB10-0354 A bill for an ordinance approving and providing for the execution of a proposed contract between the City and County of Denver and the State of Colorado concerning the "Mountain Parks Genesee Overlook" project and the funding therefor. (PUBLIC AMENITIES)

Accepts and appropriates \$92,529.52 from a Colorado Department of Transportation grant for construction of a new bison overlook at Genesee Mountain Park. The Committee approved filing this bill by consent on 5-7-10.

CB10-0327 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and Kaiser Permanente concerning the "Free Recreation Centers for Youth FY10" program and the funding therefor. (PUBLIC AMENITIES)

Accepts \$150,000 grant from Kaiser Permanente to provide youth free access to recreation centers and outdoor pools during summer 2010. The Committee approved filing this bill by consent 4-30-10.

CB10-0347 A bill for an ordinance approving an agreement between Brodart Co. and the City & County of Denver to provide cost effective and timely provisions of library collections and vendor services. (PUBLIC

AMENITIES)

Approves a \$1,885,000 contract with Brodart Co. for books and printed materials for Stapleton and Green Valley Ranch libraries. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The Committee approved filing this bill by consent on 5-7-10.

CB10-0411 A bill for an ordinance approving an agreement between Midwest Tape, LLC and the City & County of Denver to provide cost effective and timely provisions of library collections and vendor services. (PUBLIC AMENITIES)

Approves a \$1,685,000 contract with Midwest Tapes for audio-visual materials for Stapleton and Green Valley Ranch libraries. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The Committee approved filing this bill by consent on 5-7-10.

CB10-0362 A bill for an ordinance to correct a transcription error contained in the City Clerk Filing Number for Ordinance No. 196, Series of 2010, approving a proposed agreement between the City and County of Denver and Colorado Designsapes to accommodate anticipated change orders. (PUBLIC AMENITIES)

Corrects the City Clerk's Filing No. on Ordinance No. 196, Series 2010, amending a contract with Colorado Designsapes. The last regularly scheduled Council meeting within the 30-day review period is on 6-7-10. The Committee approved filing this bill by consent on 5-7-10.

CB10-0326 A bill for an Ordinance designating certain properties as being required for public use and authorizing use and acquisition thereof by negotiation or through condemnation proceedings including all improvements, fixtures, licenses, permits, access points and any other rights and interests related or appurtenant to properties so designated. (PUBLIC WORKS)

Approves acquisition of temporary construction easements on private property for reconstruction and repair of sidewalks on W. Virginia near Munroe Elementary School in Council District 3. The Committee approved filing this bill by consent on 4-30-10.

CB10-0414 A bill for an ordinance authorizing the purchase of capital equipment items from the "Urban Areas Security Initiative FY09-11" Special Revenue Fund budget. (SAFETY)

Approves a \$120,477 purchase of a bomb robot from iRobot Corp for the Denver Police Department using Urban Area Security Initiative (UASI) funds. The committee approved filing the bill by consent on April 9, 2010. The Committee approved filing this bill by consent 4-09-10.

CB10-0370 A bill for an ordinance approving a proposed First Amendment and Modification Agreement between the City and County of Denver and Great Divide Brewing Company to modify the existing Loan Agreement. (NEIGHBORHOOD, COMMUNITY & BUSINESS REVITALIZATION)

Approves a loan modification revision to the Great Divide Brewing Company contract to add funding in the amount of \$175,000 to finance the purchase of equipment. The last regularly scheduled Council meeting within the 30-day review period is on 5-24-10. The Committee approved filing this bill at its meeting on 4-27-10.

CB10-0332 A bill for an ordinance approving a proposed Commercial Ground Transportation Concession Agreement between the City and County of Denver and Meylo LLC, dba Big Sky Shuttle and/or Blue Sky Shuttle for counter space at Denver International Airport. (ECONOMIC DEVELOPMENT)

Approves a \$46,008 commercial ground transportation concession agreement with Meylo Inc. d/b/a/ Blue Sky Shuttle. The last regularly scheduled Council meeting within the 30-day review period is on 5-24-10. The Committee approved filing this bill by consent on 4-30-10.

CB10-0334 A bill for an ordinance approving a proposed Commercial Ground Transportation Concession Agreement between the City and County of Denver and Colorado Tour Lines LLC, dba Gray Line for counter space at Denver International Airport. (ECONOMIC DEVELOPMENT)

Approves a two-year, \$48,000 commercial ground transportation concession agreement with Colorado Tour Lines dba Gray Line. The last regularly scheduled Council meeting within the 30-day review period is on 5-24-10. The Committee approved filing this bill by consent on 4-30-10.

CB10-0333 A bill for an ordinance approving a proposed Commercial Ground Transportation Concession Agreement between the City and County of Denver and Delivery Acquisition Inc., dba Colorado Mountain Express for counter space at Denver International Airport. (ECONOMIC DEVELOPMENT)

Approves a two-year \$105,504 commercial ground transportation concession agreement with Delivery Acquisitions INC, dba Colorado Mountain Express. The last regularly scheduled Council meeting within the 30-day review period is on 5-24-10. The Committee approved filing this bill by consent on 4-30-10.

CB10-0335 A bill for an ordinance approving a proposed Commercial Ground Transportation Concession Agreement between the City and County of Denver and Green Ride Co., Inc. for counter space at Denver International Airport. (ECONOMIC DEVELOPMENT)

Approves a new two-year \$46,000 ground transportation concession agreement with Green Ride Company. The last regularly scheduled Council meeting within the 30-day review period is on 5-24-10. The Committee approved filing this bill by consent on 4-30-10.

CB10-0336 A bill for an ordinance approving a proposed Commercial Ground Transportation Concession Agreement between the City and County of Denver and Veolia Transportation on Demand, Inc. dba Supershuttle Denver, SuperShuttle Boulder and SuperShuttle of Northern Colorado for counter space at Denver International Airport. (ECONOMIC DEVELOPMENT)

Approves a two-year \$105,000 per year ground transportation concession agreement with Veolia Transportation On Demand at DIA. The last regularly scheduled Council meeting within the 30-day review period is on 5-24-10. The Committee approved filing this bill by consent on 4-30-10.

CB10-0328 A bill for an Ordinance approving a Purchase and Sale Agreement between the City and County of Denver and Mile High Church of Christ for the purchase of 3498 Albion Street, Denver, Colorado and 3499 Ash Street, Denver, Colorado. (FINANCE)

Approves the sale of two adjacent City surplus properties located at 3498 N. Albion Street and 3499 N. Ash Street to Mile High Church of Christ in the amount of \$125,000. The last regularly scheduled Council meeting within the 30-day review period is on 5-24-10. The Committee approved filing this bill by consent on 4-30-10.

CB10-0325 A bill for an Ordinance approving an amendment to a Master Purchase Order with Omeara Ford, Inc. to extend the term and change the "not to exceed" amount. (PUBLIC WORKS)

Extends through July 31, 2011, and increases to \$1.3 million the amount of a master purchase order with Omeara Ford for vehicle parts. The last regularly scheduled Council meeting within the 30-day review period is 5-24-10. The Committee approved filing this bill on consent 4-30-10.

CB10-0375 A bill for an ordinance approving an agreement between ECI Site Construction Management, Inc. and the City & County of Denver for the Parkfield Lake Park Project, Phase 3. (BOND IMPLEMENTATION)

Approves a \$6,471,000 contract with ECI Site Construction Management for Phase 3 of Parkfield Lake Park development. The last regularly scheduled Council meeting

within the 30-day review period is on 5-24-10. The Committee approved filing this bill at its meeting on 4-26-10.

CB10-0329 A bill for an ordinance approving an on-call construction agreement between Boden Construction Group, LLC and the City & County of Denver. (PUBLIC WORKS)

Approves a 3-year on-call construction services contract with Boden Construction with a total capacity of \$1.5 million and maximum work order total of \$75,000. The last regularly scheduled Council meeting within the 30-day review period is on 5-24-10. The Committee approved filing this bill by consent on 4-30-10.

CB10-0330 A bill for an ordinance approving the second amendatory on-call agreement between SlaterPaull Architects, Inc. and the City & County of Denver to increase the maximum contract amount. (PUBLIC WORKS)

Increases the on-call planning services contract with SlaterPaull Architects by \$480,000 for a new maximum of \$1,140,000. The last regularly scheduled Council meeting within the 30-day review period is on 5-24-10. The Committee approved filing this bill by consent on 4-30-10.

CB10-0376 A bill for an ordinance approving an agreement between Tower I Construction Company d/b/a Tower One Construction and the City & County of Denver for the Newton Theater Rehearsal Space Project. (BOND IMPLEMENTATION)

Approves a \$975,000 contract with Tower 1 Construction for finishing out the Newton Theatre Rehearsal space. The last regularly scheduled Council meeting within the 30-day review period is on 5-24-10. The Committee approved filing this bill at its meeting on 4-26-10.

CB10-0380 A bill for an ordinance approving a proposed Memorandum of Understanding between the City and County of Denver and Delta Dental for the 2010 dental services for the City & County of Denver employees. (General Government)

Approves the contract with Delta Dental for the 2010 dental services for Denver employees. The last regularly scheduled Council meeting within the 30-day review period is on 5-24-10. The Committee approved filing this bill at its meeting on 8-25-09.

(NEIGHBORHOOD, COMMUNITY & BUSINESS REVITALIZATION)

Authorizes a 12-month extension through September 30, 2010 and adds \$323,526 to an agreement with the Regents of the University of Colorado to provide Child Parent Psychotherapy (CPP) to abused and neglected children. These are federal funds provided through the Substance Abuse Mental Health Services Administration (SAMHSA) and the National Child Traumatic Stress Initiative (NCTSI) within the U.S. Department of Health and Human Services. The last regularly scheduled Council meeting within the 30-day review period is on 5-24-10. The Committee approved filing this bill by consent on 10-30-09.
