This request is for a lease agreement between Prospect International Airport Services LLC (Prospect) and Denver International Airport (DEN) for the Main Terminal and Concourse C to provide passenger services that require mobility assistance. Prospect is a tenant within the Main Terminal space, and this lease will establish a new term for their continued occupancy of the facility. Prospect will also acquire additional space on Concourse C. Prospects' lease will encompass 462 square feet.
