Hope you are well. It's been a long road since I first met you at Jeff Ross' house many years ago when you were first running for City Council!

I'm writing you as a homeowner, longtime resident of District 10 and as a longtime Board member at National Jewish (NJH). As you know, the hearing to consider the rezoning application for NJH will occur next Monday, November 14.

As I will be out of town that evening and cannot present my thoughts to City Council, I wanted to write to strongly urge you to support NJH's rezoning application.

I joined the Board at NJH 18 years ago in 1993 because after I toured the facility I was simply amazed at the groundbreaking, world-class research and care being provided just a few blocks from where I lived in central Denver. I am currently and have served as the Chair of NJH's Finance Committee for the past several years and can tell you first hand that the institution has come a long way since Michael Salem has taken over as CEO.
