EXECUTIVE SUMMARY

Extension of Existing Remediation Contract by One Year as Allowed by the Contract

The one-year extension allows the City to continue remediation and associated groundwater monitoring activities at existing City owned leaking underground storage tank (UST) sites. Work at the leaking UST sites is regulated and required by the State's Division of Oil and Public Safety. Additionally, the contracted company will provide investigation, remediation, and other environmental services to City departments as requested, such as may be associated with the sale of a property or preparing a plan to meet environmental requirements. Rates for certain rental equipment were increased; no changes were made to labor rates or markup.

Scope of Work

Extend the performance period for one year as allowed by the existing contract. The contract work consists of providing hazardous waste remediation services. The purpose of the work is to remediate hazardous waste, toxic substances, solid waste and petroleum contaminated sites as regulated by City, State and Federal statutes and regulations on an "as needed" basis. The work could include excavation, hauling and disposal or treatment of contaminated soil, in-situ remediation of contaminated soil, in-situ remediation of contaminated surface water and groundwater, pumping and treating contaminated water, disposal of contaminated water, remediation of indoor air, risk assessment of contaminated sites, responding to and remediation of spills, operation and maintenance of on-going remedial systems, decommissioning remedial systems, conducting fate and transport modeling, site investigation/characterization, and site restoration. The contracted company may be required to serve as an expert in litigation and preparation thereof.
