CCD agrees to reimburse Regional Transportation District thirty percent (30%) of Regional Transportation District's costs and expenses directly related to the Mall Paver Maintenance, up to three hundred thousand dollars (\$300,000.00) annually or three million dollars (\$3,000,000) for a duration of ten (10) years. Paver Maintenance includes damage to the Mall transit lanes caused by normal wear and tear, including wear and tear caused by Regional Transportation District normal bus operations.
