9 For an ordinance approving and providing for the execution of a proposed grant
10 agreement between the City and County of Denver and the Colorado Division of
11 Criminal Justice concerning the "Federal Crime Victim Compensation FY10"
12 program and the funding therefor.

15 WHEREAS, the City and County of Denver has given due consideration to said proposed
16 Grant Agreement; and

17 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY
18 OF DENVER:

19 Section 1. The proposed Grant Agreement, under CFDA No. 16.576, between the State of
20 Colorado and the City and County of Denver, which is identified as Grant No. 10-VC-2, a copy of
21 which is duly filed with the City Clerk, Filing No. 10-923, be and hereby is approved in all
22 respects.

23 Section 2. The Mayor or his lawful successor and other proper officials of the City and
24 County of Denver, in its behalf, are hereby authorized and directed to execute said Grant
25 Agreement and the Clerk and Recorder of the City and County of Denver is hereby authorized
26 and directed to attest and impress the official seal of the City and County of Denver on the Grant
27 Agreement.

28 Section 3. The Mayor, his successor in office, or his duly authorized representatives, and
29 other officials of the City are hereby authorized and directed to do all things required to be done
30 in order to obtain payments under the Grant Agreement, including, but not limited to, filing
31 requests for payments, contracting with persons and organizations in order to carry out the
32 provisions of the Grant Agreement, filing reports and keeping records relating to fiscal and
33 evaluation matters, and forwarding other materials to the State of Colorado.

34 Section 4. The payments made by the State of Colorado to the City pursuant to and under
35 the Grant Agreement shall be deposited into the Treasury of the City and credited to Special
36 Fund No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal
37 Code of the City and County of Denver.

1 Section 5. That it be and is hereby found and determined that the budget summary of said
2 "Federal Crime Victim Compensation FY10" Program, Accounting No. 12001-0401101-U2058 is
3 as follows, to be expended by the District Attorney:

5 State of Colorado \$ 1,500,000

6 Authorization for expenditure of said funds following execution of said grant will cover the period
7 from October 1, 2010 to September 30, 2011.

8 Section 6. The Manager of Finance of the City and County of Denver is hereby authorized
9 and directed to make such book and record entries and to do such other things as may be
10 necessary to accomplish the purposes of this Ordinance.
