5 **Approving and providing for the execution of a proposed Grant Agreement**
6 **between the City and County of Denver and the Colorado Department of**
7 **Transportation concerning the “Colfax Bus Rapid Transit” program and the**
8 **funding therefor.**

10 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
11 Grant Agreement;

13 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**
14 **OF DENVER:**

16 **Section 1.** The proposed Grant Agreement between the City and County of Denver and the
17 Colorado Department of Transportation for the “Colfax Bus Rapid Transit” program, which is
18 identified as Grant Number 23-HA1-XC-00176, a copy of which is duly filed with the City Clerk, Filing
19 No. 202366922, be and hereby is approved in all respects.

20 **Section 2.** The payments made by the Colorado Department of Transportation to the City
21 pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and
22 credited to Special Fund No. 38000, which is set forth and described in Section 20-18 of the Revised
23 Municipal Code of the City and County of Denver.

24 **Section 3.** That it be and is hereby found and determined that the budget summary of said
25 program, to be expended by the Executive Director of the Department of Transportation and
26 Infrastructure, is as follows:
