8 **Approving and providing for the execution of a proposed grant agreement**
9 **between the City and County of Denver and The Wallace Foundation**
10 **concerning the "Wallace Foundation's Partnership for Social and Emotional**
11 **Learning Initiative" program and the funding therefor.**

14 **WHEREAS**, The Wallace Foundation has awarded the Denver Afterschool Alliance within
15 the Office of Children's Affairs a grant under a contractual agreement with the City, and;

16 **WHEREAS**, The Wallace's Partnerships for Social and Emotional Learning Initiative seeks
17 to foster children's social and emotional learning through partnerships between the school district
18 and the City to support students' social and emotional development;

19 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
20 **OF DENVER:**

21 **Section 1.** The proposed Grant Agreement between The Wallace Foundation and the City
22 and County of Denver, a copy of which is duly filed with the City Clerk, Filing No. 17-0420, be
23 and hereby is approved in all respects.

24 **Section 2.** The payments made by The Wallace Foundation to the City pursuant to and
25 under the Grant Agreement shall be deposited into the Treasury of the City and credited to
26 Special Fund No. 11000, which is set forth and described in Section 20-18 of the Revised
27 Municipal Code of the City and County of Denver.

28 **Section 3.** That it be and is hereby found and determined that the budget summary of said
29 "Wallace's Partnerships for Social and Emotional Learning Initiative" program, Accounting No.
30 11607-0103100-CCD0452 is as follows, to be expended by the Director of the Office of
31 Children's Affairs:
