Scope of work:

Description of Activity: The participant population to be served consists of low-income people living with HIV/AIDS who need assistance with maintaining long-term, stable, permanent housing. Assistance may be provided after review of the participant's eligibility and other requirements.

<u>Tenant Based Rental Assistance</u> (TBRA): The TBRA Program will provide housing assistance to eligible households. TBRA meets the needs of participants by subsidizing the difference between total rent and the monthly tenant rent (based on Tenant Rent Calculation Worksheet or other approved form), to be calculated and tracked by staff at Denver Colorado AIDS Project (DCAP), or the referring agency, and paid out by DCAP.

Short Term Rent Mortgage Utility Assistance (STRMU): The STRMU Program will provide housing assistance to eligible households for up to \$1,200 and/or 21 weeks of assistance in a 52-week period. This program is designed to prevent homelessness by assisting to retain long-term, stable, permanent housing options for households that might otherwise lose their housing. This program provides STRMU in the form of eviction/foreclosure prevention.

<u>Supportive Services</u>: Collaboration with other case management services offered through DCAP such as referrals to healthcare, support around adherence to healthcare and treatment, referrals to mental health and substance abuse counseling, referrals to support groups and psycho-educational workshops, housing resources and referrals, and vocational assistance. The services are targeted to participants that live in HOPWA-supported, Section 8, and other privately owned housing. Case managers assigned directly to participants will help to ensure that they maintain a stable

housing environment. The case managers will work closely with landlords and developers as well as the participants so that they remain in their homes as long as possible. Participants will have access to referrals for substance abuse and mental health treatment counseling, if they have a need for those services.

<u>Permanent Housing Placement</u>: The Permanent Housing Placement Program will provide deposit/move-in assistance to eligible participants.

EXECUTIVE SUMMARY

Per direction from the U.S. Department of Housing and Urban Development (HUD), Housing Opportunities for People With AIDS (HOPWA) funds are used for a wide range of housing, social services, program planning, and development costs. These may include the acquisition, rehabilitation, or new construction of housing units; costs for facility operations; rental assistance; and short-term payments to prevent homelessness.

An essential component in providing housing assistance for this targeted special needs population is the coordination and delivery of support services. Thus HOPWA funds also may be used for assessment and case management, substance abuse treatment, mental health treatment, nutritional services, job training and placement assistance, and assistance with daily living.

Low-income persons at or below 80% AMI that are medically diagnosed with HIV/AIDS and their families are eligible to receive HOPWA-funded assistance. Denver contracts with public and nonprofit providers to deliver HOPWA-funded services, including the Colorado Health Network. Last year, Colorado Health Network and its community-based subcontractors served 99 households with Tenant-Based Rental Assistance, 113 households with Short-term Rent Mortgage Utility Assistance (STRMU) and 146 households with Permanent Housing Placement (PHP). Of those served, all were at or below 30% AMI and/or people experiencing homelessness. In addition, OED's funds were used to leverage an additional \$2,326,935.

HOPWA funds fulfill the goal of the city's annual Action Plan and five-year Comprehensive Housing Plan by helping households stay in their existing housing through rental, mortgage, and utility assistance as well as supportive services. Furthermore, the Permanent Housing Placement program helps people access affordable rental housing by providing deposit/move-in assistance to eligible participants. Finally, most of the individuals utilizing these funds are at or below 30% AMI and/or people experiencing homelessness. The five-year comprehensive housing plan has a goal of "40 to 50% of housing resources [be] invested to serve residents earning below 30% of Area Median Income (AMI) and those experiencing homelessness who are seeking to access or maintain rental housing."
