South Platte River

A BILL

For an ordinance changing the zoning classification for 4458 North Pearl Street in Globeville, 5275 North Franklin Street in Globeville, and 4621 North Telluride Street in Globeville Green Valley Ranch.

WHEREAS, the City Council has determined, based on evidence and testimony presented at the public hearing, that the map amendment set forth below conforms with applicable City laws, is consistent with the City’s adopted plans, is in the public interest, and is consistent with the neighborhood context and the stated purpose and intent of the proposed zone district;

NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That upon consideration of a change in the zoning classification of the land area hereinafter described, Council finds:

- a. The land area hereinafter described is presently classified as U-MX-3, I-B, and PUD 319.
- b. It is proposed that the land area hereinafter described be changed to OS-A.

Section 2. That the zoning classification of the land area in the City and County of Denver described as follows shall be and hereby is changed from U-MX-3, I-B, and PUD 319 to OS-A:

Re-Zone of Portions of Parcels
Schedule No. 0214200030000 1401 E. 53rd Ave.
Schedule No. 0214300153000 955 E. 51st Ave.

A parcel of land lying within the West half of Section 14, Township 3 South, Range 68 West, of the Sixth Principal Meridian, in the City and County of Denver, State of Colorado, described as follows:

Commencing at a point on the South line of the Northwest Quarter of said Section 14, S89°48’57”W, a distance of 225.96 feet from the Center corner of said Section 14, said point also being on the Northwesterly line of the official channel of the South Platte River, Ordinance No. 33, Series of 1926, City and County of Denver records; Thence S46°44’11”W, along said Northwesterly line, a distance of 338.94 feet to the most Southeasterly corner of the National Guard Lease Parcel; Thence S46°44’11”W, continuing along said Northwesterly line, a distance of 940.00 feet; Thence N43°15’49”W, leaving said Northwesterly line, a distance of 25.00 feet to a point of curve; Thence along the arc of a tangent curve to the left, having a central angle of 29°34’47”, a radius of 394.46 feet, an arc length of 203.65 feet to a point on

1 the right-of-way line of East 51st Avenue; Thence N00°00'00"E, along said right-of-
2 way and along the right-of-way line of Downing Street, a distance of 154.72 feet to a
3 point of curve; Thence continuing along said Downing Street right-of-way line, along
4 the arc of a tangent curve to the right, having a central angle of 8°01'35", a radius of
5 460.00 feet, an arc length of 64.44 feet to The Point of Beginning; Thence continuing
6 along said Downing Street right-of-way line the following four courses:

- 7 1) Along the arc of a reverse curve to the left, the center of which bears N81°58'25"W,
- 8 having a central angle of 260°05'11", a radius of 65.00 feet, an arc length of 295.06
- 9 feet to the intersection of a non-tangent curve;
- 10 2) Thence along the arc of a non-tangent curve to the left, the center of which bears
- 11 S88°47'01"E, a distance of 540.00 feet, having a central angle of 1°12'59", a radius
- 12 of 540.00 feet, an arc length of 11.47 feet to a point of tangent;
- 13 3) Thence S00°00'00"W, a distance of 95.91 feet to a point of curve;
- 14 4) Thence along the arc of a tangent curve to the right, having a central angle of
- 15 89°48'57", a radius of 30.00 feet, an arc length of 47.03 feet to the North right-of-way
- 16 line of said East 51st Avenue;

17 Thence S89°48'57"W, along said North right-of-way line, a distance of 532.97 feet to
18 the East right-of-way line of Emerson Street; Thence N00°06'23"W, along said East
19 right-of-way line, a distance of 719.00 feet to a point of intersection with the North line
20 of the SW1/4 of said section; Thence S89°48'57"W, along said North line, a distance
21 of 30.00 feet; Thence N00°06'23"W, a distance of 500.00 feet; Thence N89°48'57"E,
22 a distance of 810.93 feet to a point of tangent on the North right-of-way line of East
23 53rd Avenue; Thence along the right-of-way line of said East 53rd Avenue the
24 following three courses:

- 25 1) Thence S78°56'31"W, a distance of 130.84 feet;
- 26 2) Thence S00°00'00"W, a distance of 81.57 feet;
- 27 3) Thence N78°56'31"E, a distance of 106.52 feet to a point of non-tangent curve;
- 28 Thence Southwesterly, along the arc of a curve to the left, the center of which bears
- 29 S11°03'29"E, a distance of 30.00 feet, having a central angle of 78°56'31", a radius
- 30 of 30.00 feet, an arc length of 41.33 feet to a point; Thence S00°00'00"W, a distance
- 31 of 568.74 feet to a point of curve; Thence along the arc of a curve to the right, having
- 32 a central angle of 24°10'17", a radius of 540.00 feet, an arc length of 227.81 feet to a
- 33 point of reverse curve; Thence along the arc of a reverse curve to the left, having a
- 34 central angle of 16°08'42", a radius of 460.00 feet, an arc length of 129.62 feet to The
- 35 Point of Beginning.

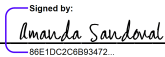
