**A BILL**

**For an Ordinance approving a proposed Intergovernmental Agreement between the City and County of Denver and Evergreen Fire Protection District to procure interoperable communications equipment.**

**WHEREAS**, the City and County of Denver and the Evergreen Fire Protection District propose to enter into an Intergovernmental Agreement for interoperable communications equipment; and

**WHEREAS**, the proposed Intergovernmental Agreement between the City and County of Denver and the Evergreen Fire Protection District cannot be executed by proper officials of the City and County of Denver until it has been approved by the City Council pursuant to Section 29-1-203, Colorado Revised Statutes, because it involves the delineation and sharing of governmental functions between the City and County of Denver and the Evergreen Fire Protection District; and

**WHEREAS**, the City and County of Denver has given due consideration to entering into the proposed Intergovernmental Agreement for accomplishment of the purposes described therein;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed Intergovernmental Agreement between the City and County of Denver and the Evergreen Fire Protection District for interoperable communications equipment; in the words and figures contained and set forth in that form of proposed Intergovernmental Agreement, filed in the office of the Clerk and Recorder, Ex-Officio Clerk of the City and County of Denver, on the 21<sup>st</sup> day of October, 2010, City Clerk's Filing No. 10- 1064, is hereby approved.

**Section 2.** The Auditor and Treasurer of the City and County of Denver are hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
