CR15-0404 A Resolution authorizing and approving the expenditure and payment from the appropriation account designated "Liability Claims," the sum of Four Hundred Thirty-Seven Thousand Five Hundred Dollars (\$437,500), payable to THE LAW OFFICES OF WILL AITCHISON, pursuant to the court-approved settlement agreement in Civil Action No. 07-cv-00541-RPM, in the United States District Court for the District of Colorado.

Settles a claim involving the Denver Police Department. This Resolution was approved to be filed at the Mayor-Council meeting on 6-2-15.

CB15-0350 A bill for an ordinance approving a proposed Agreement

between the City and County of Denver and the Federal Aviation Administration, related to a ground lease for TRACON Facility at Denver International Airport.

Approves a 20-year lease with the Federal Aviation Administration (FAA) in the amount of \$888,969.60 ending on 9-30-35 for the land upon which the FAA's Technical Operations Center and "TRANCON" Air Traffic Control Operations facilities are located on Denver International Airport property (201520836). The last regularly scheduled Council meeting within the 30-day review period is on 6-29-15. The Committee approved filing this bill by consent on 5-28-15.

CB15-0351 A bill for an ordinance approving a proposed Third Amendment to Agreement between the City and County of Denver and IHCS dba Maven Asset Management, Inc. related to on-call technology maintenance and support services at Denver International Airport.

Amends a contract with IHCS, Inc. doing business as Maven Asset Management by adding \$100,000 for a new contract total of \$592,000 and extending the contract by one year through 10-19-16 for on-call system support services for the Maximo software application at Denver International Airport (201100494-03). The last regularly scheduled Council meeting within the 30-day review period is on 6-29-15. The Committee approved filing this bill by consent on 5-28-15.

CB15-0367 A bill for an ordinance approving a proposed Third Amendment to Agreement between the City and County of Denver and Host International, Inc., concerning a concession space at Denver International Airport.

Amends the agreement with Host International, Inc., doing business as Rock Bottom Restaurant & Brewery, to expand the square footage of Rock Bottom Restaurant & Brewery by more than 20% to utilize adjacent vacant space at Denver International Airport (AR 78004). The last regularly scheduled Council meeting within the 30-day review period is on 6-29-15. The Committee approved filing this bill by consent on 5-28-15.

CB15-0311 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and W.L. Contractors, Inc. for

replacement of a traffic signal and traffic sign bridge.

Approves a \$1,107,294.21 contract with W.L. Contractors, Inc. to replace the existing traffic signal on the Evans Avenue bridge at Santa Fe Drive and the traffic sign bridge at South Platte River Drive south of Mississippi Avenue in Council District 7 (201520020). The last regularly scheduled Council meeting within the 30-day review period is on 6-29-15. The Committee approved filing this bill by consent on 5-21-15.

CB15-0341 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Goodland Construction, Inc., for construction of a bike park in Ruby Hill Park.

The last regularly scheduled Council meeting within the 30-day review period is on 6-29-15. The Committee approved filing this bill by consent on 5-21-15.

CB15-0358 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Humphries Poli Architects, P.C., for architectural and engineering professional services in support of the McNichols Building Redevelopment.

Adds \$95,661 for a new total of \$584,395 to the contract with Humphries Poli Architects for additional design services for the McNichols Redevelopment Phase 2 project in Council District 10. The last regularly scheduled Council meeting within the 30-day review period is on 6-29-15. The Committee approved filing this bill by consent on 5-21-15.

CB15-0346 A bill for an ordinance changing the zoning classification of 301 S. Cherokee Street.

Rezones property located at 301 South Cherokee Street from I-B/UO-2 (General Industrial, Use Overlay Allowing Billboards) and C-MX-16/UO-2 (Urban Center, Mixed Use, 16 stories) to PUD/OU-2 (Planned Unit Development, Use Overlay Allowing Billboards) in Council District 7. Approves a contract with Kids Crossing, for \$2,180,858 through 6-30-18 to provide placements and case management services to children in out-of-home care (2015-21830). The last regularly scheduled Council meeting within the 30-day review period is on 6-29-15. The Committee approved filing this bill by consent on 5-14-

15.

CB15-0318 A bill for an ordinance approving a proposed Third Amendatory Agreement to the Concession Agreement between the City and County of Denver and Work Options for Women concerning cafeteria operations at the Denver Department of Human Services, 1200 Federal Blvd., Denver, CO.

Amends a contract with Work Options for Women to add an additional term through 6-30-16 to provide cafeteria services for the Denver Department of Human Services located at 1200 Federal Boulevard. No additional costs added (RC55006-03). The last regularly scheduled Council meeting within the 30-day review period is on 6-29-15. The Committee approved filing this bill by consent on 5-14-15.

CB15-0343 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the State of Colorado concerning the "Community Services Block Grant (CSBG) FY15-16" program and the funding therefor.

Accepts the Community Services Block Grant (CSBG) award provided by the State of Colorado Department of Local Affairs in the amount of \$1,021,869 for fiscal year 2015-2016 to deliver services and/or provide assistance to low income families and individuals (SOCSV-2015-22154). The last regularly scheduled Council meeting within the 30-day review period is on 6-29-15. The Committee approved filing this bill by consent on 5-28-15.

CB15-0344 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Parker Personal Care Homes, Inc. to provide Out-of-Home Placement Services for children/youth in the custody of the Department of Human Services.

Approves a contract with Parker Personal Care Homes, Inc. through 6-30-18 for \$713,502 to provide placements and case management services to children in out-of-home care (2015-22200). The last regularly scheduled Council meeting within the 30-day review period is on 6-29-15. The Committee approved filing this bill by consent on 5-28-15.

CB15-0363 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Families First, Inc. to provide Out-of-Home Placement Services for children/youth in the custody of the Department of Human Services.

Approves a contract with Families First, Inc. for \$656,842 through 6-30-18 to provide placements and case management services to children in out-of-home care (2015-22257). The last regularly scheduled Council meeting within the 30-day review period is on 6-29-15. The Committee approved filing this bill by consent on 5-28-15.

CB15-0369 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and B.I. Incorporated.

Amends a contract with BI, Inc. to provide better service locally and nationally to

monitor offenders under supervision with the Electronic Monitoring Program. No changes to the contract term or amount (2013-14300). The last regularly scheduled Council meeting within the 30-day review period is on 6-29-15. The Committee approved filing this bill by consent on 5-28-15.

CB15-0370 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Alcohol Monitoring Systems, Inc.

Amends a contract with Alcohol Monitoring Systems Inc. to provide better service locally and nationally by adding the use of Ethernet communication to monitor offenders under supervision with the Electronic Monitoring Program. CB15-0254 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Panasonic Enterprise Solutions Company, to create 250 jobs at their business solutions, operations and technology center.

Approves a contract with Panasonic Energy Solutions Company (PESCO) to provide a \$1.35 million Business Incentive Fund (BIF) reimbursable grant for the purposes of creating 250 jobs at their business solutions, operations and technology center, located at the 61st and Peña Boulevard light rail station in Council District 11. The last regularly scheduled Council meeting within the 30-day review period is on 6-15-15. The Committee approved filing this bill at its meeting 4-28-15.

CB15-0281 A bill for an ordinance approving a proposed Contract between the City and County of Denver and Alpine Disposal, Inc., d/b/a Alpine Waste and Recycling related to waste disposal and recycling services at Denver International Airport.

Approves a contract with Alpine Disposal, Inc. doing business as Alpine Waste and Recycling in the amount of \$7 million through 8-31-20 for collection and transport of trash, recycling, and compostable materials at Denver International Airport (201419733). The last regularly scheduled Council meeting within the 30-day review period is on 6-15-15. The Committee approved filing this bill by consent on 5-14-15.

CB15-0303 A bill for an Ordinance approving a proposed Cooperation Agreement between the City and County of Denver and The Denver Urban Renewal Authority for the Amended and Restated Ironworks Foundry Urban Redevelopment Area.

Approves a cooperation agreement with the Denver Urban Renewal Authority for the Amended and Restated Ironworks Foundry Urban Redevelopment Area to establish, among other matters, the parameters for tax increment financing with property tax increment and sales tax increment in Council District 9. The last regularly scheduled Council meeting within the 30-day review date is on 6-22-15. The Committee approved filing this bill at its meeting on 5-13-15.

CB15-0305 A bill for an ordinance making supplemental appropriations from the General Contingency Fund to the Sheriff department.

Approves a supplemental budget appropriation to the Denver Sheriff Department to raise the salaries of members of the Sheriff Department's bargaining unit by 2.7%, which equates to an increase of \$1,802,271, as part of the Collective Bargaining Agreement. The Committee approved filing this bill by consent on 5-21-15.

CB15-0314 A bill for an ordinance referring a question to the ballot at the November 3, 2015 coordinated election concerning the retention and continuation of the special retail marijuana sales tax originally approved by the voters at the November 5, 2013 election.

Refers a question to the November 2015 ballot to allow the City to retain and spend all 2014 marijuana special sales tax revenues as previously approved by the voters and to continue to impose and collect the tax per the original voter approval. This bill must pass no later than August 31, 2015 to meet the deadlines for the November ballot. The Committee approved filing this bill at its meeting on 5-13-15.

CB15-0315 A bill for an ordinance approving a proposed Community Solar Services Agreement between the City and County of Denver and Denver Community Solar Garden I LLC to provide solar energy.

Approves a \$1,334,276 contract with Denver Community Solar Garden I for solar energy for eight City facilities over a twenty-year term through 12-31-35 (GENRL-201521196-00). The last regularly scheduled Council meeting within the 30-day review period is on 6-22-15. The Committee approved filing this bill by consent on 5-21-15.

CB15-0316 A bill for an ordinance approving a proposed Community Solar Services Agreement between the City and County of Denver and Denver Community Solar Garden II LLC to provide solar energy.

Approves a \$1,334,276 contract with Denver Community Solar Garden II for solar energy for eight City facilities over a twenty-year term through 12-31-35 (GENRL-201521195-00). The last regularly scheduled Council meeting within the 30-day review period is on 6-22-15. The Committee approved filing this bill by consent on 5-21-15.

CB15-0352 A bill for an ordinance approving a proposed Installment Purchase Agreement between Santander Leasing LLC and the City and County of Denver, to purchase new technology services equipment for Denver International Airport.

Authorizes the Manager of Finance to provide financing through a capital lease purchase transaction on behalf of the Department of Aviation to purchase new technology services equipment for Denver International Airport in a principal amount not to exceed \$3,987,615 (PLANE-201521045-00). The last regularly scheduled Council meeting within the 30-day review period is on 6-22-15. The Committee approved filing this bill by consent on 5-21-15.

Infrastructure & Culture

CB15-0310 A bill for an ordinance vacating the right-of-way between Lawrence Street, Arapahoe Street, 26th Street and 27th Street, with reservations.

Vacates an alley at 2626 Lawrence Street for redevelopment as "Sustainability Park" in Council District 8. The Committee approved filing this bill by consent on 5-21-15.

CB15-0340 A bill for an ordinance approving and providing for the execution of a proposed Intergovernmental Agreement between the City and County of Denver and the Colorado Department of Public Health and Environment (CDPHE) concerning the "Westerly Creek from 33rd Avenue and the Confluence of Sand Creek" project and the funding therefor.

Accepts and establishes a new capital grant fund and appropriation for a \$1,842,951 grant from the Colorado Department of Public Health and Environment for improvements to Denver's Westerly Creek from 33rd Avenue and the Confluence of Sand Creek in Council District 11. The last regularly scheduled Council meeting within the 30-day review period is on 6-22-15. The Committee approved filing this bill by consent on 5-21-15.

CB15-0348 A bill for an ordinance approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the Colorado Department of Natural Resources concerning the "River Vision Improvement Plan (RVIP)" project and the funding therefor.

Accepts and establishes a new capital grant fund and appropriation for a \$1.5 million grant from the Colorado Department of Natural Resources for construction of the River Vision Implementation Plan (RVIP), including improvements to the South Platte River and Grant Frontier and Pasquinel's Landing Parks from West Iliff Avenue north to West Florida Avenue in Council District 7 (RM01312_004). The last regularly scheduled Council meeting within the 30-day review period is on 6-22-15. The Committee approved filing this bill by consent on 5-21-15.

CB15-0349 A bill for an ordinance revoking the revocable permit granted by Ordinance No. 35, Series of 2004, to Regional Transportation District.

Revokes Ordinance No. 35, Series of 2004, which granted a revocable permit to the Regional Transportation District to encroach into the right-of-way with a variety of items at 16th Street between Blake Street and Market Street in Council District 9. The Committee approved filing this bill by consent on 5-21-15.

CB15-0353 A bill for an ordinance vacating a portion of right-of-way north of 3525 West 22nd Avenue, with reservations.

Vacates a 40 by 13 foot portion of the alley to the north of 3525 West 22nd Avenue in Council District 1. The Committee approved filing this bill by consent on 5-21-15.

CB15-0354 A bill for an ordinance vacating a portion of right-of-way between 2345 7th Street and 695 Water Street, with reservations.

Approves a contract with Savio House Child Placement Agency for \$3,111,840 through 6-30-18 to provide placements and case management services to children in out-of-home care (2015-21831). The last regularly scheduled Council meeting within the 30-day review period is on 6-22-15. The Committee approved filing this bill by consent on 5-14-15.

CB15-0277 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Maple Star Colorado to provide Out-of-Home Placement Services for children/youth in the custody of the Department of Human Services.

Approves a contract with Maple Star Colorado for \$611,554 through 6-30-18 to provide placements and case management services to children in out-of-home care (2015-21822). CB15-0280 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and El Pueblo Boys' & Girls' Ranch, Inc. to provide Out-of-Home Placement Services for children/youth in the custody of the Department of Human Services.

Approves a contract with El Pueblo Boys' & Girls' Ranch, Inc. for \$1,414,159 through 6-30-18 to provide placements and case management services to children in out-of-home care (2015-21826). The last regularly scheduled Council meeting within the 30-day review period is on 6-15-15. The Committee approved filing this bill by consent on 5-14-15.

CB15-0282 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Shiloh Home, Inc to provide Out-of-Home Placement Services for children/youth in the custody of the Department of Human Services.

Approves a contract with Shiloh House for \$631,616 through 6-30-18 to provide placements and case management services to children in out-of-home care (2015-21941). The last regularly scheduled Council meeting within the 30-day review period is on 6-15-15. The Committee approved filing this bill by consent on 5-14-15.

CB15-0288 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Catholic Charities and Community Services of the Archdiocese of Denver to provide Head Start programs and services through June 30, 2016.

Approves a contract with Catholic Charities and Community Services of the Archdiocese of Denver in the amount of \$1,510,802 and through 6-30-16 to provide comprehensive Head Start services to 224 children, ages 3 to 5 years old (MOEAI 201512057). The last regularly scheduled Council meeting within the 30-day review period is on 6-15-15. The Committee approved filing this bill by consent on 5-14-15.

CB15-0289 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Clayton Early Learning, Trustee, George W. Clayton Trust, to provide Head Start programs and services through June 30, 2016.

Approves a contract with Clayton Early Learning, Trustee, George W. Clayton Trust in the amount of \$1,424,825 and through 6-30-16 to provide direct Head Start services to 236 children (MOEAI 201512058). The last regularly scheduled Council meeting within the 30-day review period is on 6-15-15. The Committee approved filing this bill by consent on 5-14-15.

CB15-0290 A bill for an ordinance authorizing expenditures in the General Government Special Revenue Fund based on a letter of intent from United States of America to award funding for the "Head Start Grant FY 2015-16" program.

Appropriates \$7.1 million of the Federal Head Start grant (full award amount \$8,939,277) to operate the Denver Great Kids Head Start program through the Office of Children's Affairs. The Committee approved filing this bill by consent on 5-14-15.

CB15-0292 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Mile High Montessori Early Learning Centers to provide Head Start programs and services through June 30, 2016.

Approves a contract with Mile High Montessori Early Learning Centers for \$1,682,721 and through 6-30-16 to provide direct Head Start services to 269 children (MOEAI 201512060). The last regularly scheduled Council meeting within the 30-day review period is on 6-15-15. The Committee approved filing this bill by consent on 5-14-15.

CB15-0297 A bill for an ordinance approving a proposed Fifth Amendatory Agreement between the City and County of Denver and Century Helicopters, Inc.

Amends an agreement with Century Helicopters, Inc. by adding a twelve-month extension for a new end date of 6-30-16 for scheduled and nonscheduled maintenance of the Denver Police Department's helicopter. Approves the Collective Bargaining Agreement with the Fraternal Order of Police, Denver Sheriff Lodge 27 for pay and benefits for the year 2015. The final agreement includes a reinstatement of the General Election Day holiday observed in even-numbered years and a 2.7% salary increase. The Committee approved filing this bill by consent on 5-19-15.

CB15-0308 A bill for an ordinance amending Chapter 22 of the Revised Municipal Code to establish the 2015, 2016, 2017 and 2018 salary of the Fire Chief, Deputy Chief and Division Chiefs.

Amends Chapter 22 of the Denver Revised Municipal Code to establish the 2016, 2017, and 2018 salary of the Fire Chief, Deputy Chief, and Division Chiefs, and includes reopening the 2013-2015 CBA to increase 2015 salary. Increases will be 1.5% on 7-1-15; 3.5% increase on 1-1-16; 2% increase on 1-1-17; 2% increase on 7-1-17; and a 3% increase on 1-1-18. The Committee approved filing this bill by consent on 5-19-15.

CB15-0326 A bill for an ordinance approving a First Amendment to Fiscal Year 2015 Amendment to the Amended and Restated Operating Agreement with Denver Health and Hospital Authority to provide emergency medical services to Englewood.

Approves an agreement with Denver Health and Hospital Authority to assist in providing fire and emergency medical services to Englewood, including 2 ambulances in the jurisdiction at all times. This agreement is a companion to the intergovernmental agreement with Englewood to provide Fire and EMS services, will cover 6-1-15 through 12-31-15, and will be folded into the Operating Agreement for 2016 and future years. The last regularly scheduled Council meeting within the 30-day review period is on 6-22-15. The Committee approved filing this bill by consent on 5-14-15.
