A BILL

For an ordinance making a rescission from General Fund Contingency, and making a cash transfer to and an appropriation in the Capital Improvements and Capital Maintenance Fund.

WHEREAS, the City wishes to purchase the Tooley Hall Building, a community corrections facility, which would be approved through companion ordinance CB19-1340; and

WHEREAS, sufficient resources remain in the 2019 General Fund Contingency to support the purchase via a transfer to the Capital Improvement Program;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the General Fund there is hereby RESCINDED the amount listed or indicated in the following tabulation under the heading "Amount Rescinded" and transferred to the General Fund:


