A RESOLUTION

Accepting and approving the plat of Stapleton Filing No. 54.

WHEREAS, the property owners of the following described land, territory or real property situate, lying and being in the City and County of Denver, State of Colorado, to wit:

A part of Section 10, Township 3 South, Range 67 West of the Sixth Principal Meridian, City and County of Denver, State of Colorado, more particularly described as follows:

18 State Plane Coordinates. The South Quarter Corner of said Section 10 is a found 3-1/4" aluminum

19 Cap in a Monument Box Stamped: PLS 27936. The Southeast Corner of said Section 10 is a

20 found 3-1/4" aluminum Cap in a Monument Box Stamped ZBS INC PLS 11434.

23 and have submitted to the Council of the City and County of Denver a plat of such proposed

24 subdivision under the name and style aforesaid, showing the adjacent streets and platted territory,

25 accompanied by a certificate of title from the attorney for the City and County of Denver; and

26 **WHEREAS**, said subdivision was surveyed by or under the direction of the City Engineer of the

27 City and County of Denver and said City Engineer has certified as to the accuracy of said survey and

28 said plat or map and their conformity with the requirements of Chapter 49, Article III of the Revised

29 Municipal Code of the City and County of Denver, and said plat has been approved by the City

30 Engineer, the Executive Director of Community Planning and Development, the Executive Director of

31 Public Works and the Executive Director of Parks and Recreation;

32 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

33 **Section 1.** That the Council hereby finds and determines that said land, territory, or real

34 property has been platted in strict conformity with the requirements of the Charter of the City and

35 County of Denver.

36 **Section 2.** That the said plat or map of Stapleton Filing No. 54 be and the same are hereby

37 accepted by the Council of the City and County of Denver.
