### 5. General description or background of proposed request. Attach executive summary if more space needed:

State law requires a public hearing be conducted prior to City Council approving the creation of a general improvement district and the general improvement district's annual work plan and budget. This legislative item is the first of two items related to the formation and establishment of the general improvement district. This resolution will reserve a public hearing on August 4, 2025. The second legislative item will be an ordinance seeking approval of the petition, proposed creation ordinance, and 2025 and 2026 work plan and budget.

The proposed Broadway Denver General Improvement District boundaries can generally be described as 6<sup>th</sup> Ave to the North, properties on the western edge of Lincoln Blvd to the East, I-25 to the South, and properties along the western edge of Lincoln Blvd to the East. The proposed district will support safety and security services, cleaning services, community ambassador services, and public facing streetscape/pedestrian infrastructure improvements.
