A RESOLUTION

Laying out, opening and establishing as part of the City street system a parcel of land as East 32nd Avenue, located at the intersection of North Central Park Boulevard and East 32nd Avenue.

BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:
