A BILL

For an ordinance amending Ordinance No. 301, Series of 1987, concerning the “Family Crisis Center” Special Revenue Fund (13802) to update outdated language to expand the allowable purpose of the fund.

WHEREAS, Ordinance No. 301 Series of 1987 established Fund 13802, a Denver Human Services (DHS) Special Revenue Fund to receive donations to be used for operational costs and services provided in connection with programs and events of the Family Crisis Center; and

WHEREAS, DHS previously used the Family Crisis Center to provide residential care to children in its custody for many years, but the facility was closed in the summer of 2016 with no intention of reopening it for that purpose due to changes in child welfare practice; and

WHEREAS, said ordinance is written in a way that prevents DHS from spending the balance in said fund; and

WHEREAS, the City wishes to update the ordinance language to align with DHS current needs;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That Section 3 of Ordinance 301, Series of 1987, is hereby amended to read as follows:

“Section 3. Funds shall be used for operational costs and services provided in connection with programs and events of the Family Crisis Center, or for any purposes that support families and children involved in the child welfare system.”

1 **Section 2.** The Chief Financial Officer of the City and County of Denver is hereby authorized
2 and directed to make such book and record entries and to do such other things as may be necessary
3 to accomplish the purposes of this Ordinance.


