9 **For an ordinance amending the annual salary of the Director of Excise and**  
10 **Licenses**

13 WHEREAS, Colorado Constitution Art. XX, Sec. 2 requires that the compensation of the  
14 officers of the City and County of Denver be expressed as a stated salary fixed by ordinance within  
15 limits fixed by the Charter; and

16 WHEREAS, in accordance with § 9.2.3 of the Charter the Career Service Board has  
17 determined a pay range for the Director of Excise and Licenses, one of the appointed charter  
18 officers listed in § 9.2.1 (B) of the Charter; and

20 WHEREAS, the annual salary set forth herein does not exceed the maximum salary set forth in  
21 the pay range determined by the Career Service Board, as required by § 9.2.3 of the Charter; and

23 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
24 **DENVER:**

25 **Section 1.** That Chapter 18, Article III, Division 2, Section 18-91 of the Revised Municipal Code  
26 is hereby amended by adding the language underlined and deleting the language stricken to read as  
27 follows:

28 **Section 18-91. Salaries.**

30 The career service board having determined limits of the salaries of appointed  
31 charter officers in accordance with the limitations of section 9.2.3 of the Charter, the  
32 council hereby fixes the annual salaries as follows:
