The services provided by SHALOM Denver will support TANF-eligible individuals as determined by the Denver Department of Human Services. These services will further the goal of the Colorado Works/TANF program which pertains specifically to job preparation and employment.

As a renewed contractor with OED, SHALOM Denver works with Denver TANF participants to prepare for, enter, and maintain employment. SHALOM serves customers who have learning disabilities or cognitive issues, or dual diagnosis with mental health issues, and also assists appropriate SSI/SSDI applicants to appeal unfavorable SSI/SSDI decisions. Under OED's direction, the job search services that SHALOM provides includes three categories of activities:

Classroom-based job search preparation

- Teach job search strategies and techniques
- Develop effective job search tools

Structured job search activities

- Monitor job search activities and progress
- Ensure compliance with the job search plan
- Modify job search strategies and plan as needed to strengthen hiring potential
- Provide ongoing job search support and encouragement

Community-based training (CBT)

- Utilized to increase participants' employability
- Aligns with defined career goals
- Creates networking opportunities

with these jobseekers.

Job search curriculum, structure, and percentages of each category of activity will be approved by OED. OED receives a day-by-day description of the first four weeks that the customer is engaged in his/her job search. All written materials provided to the customer are written at no greater than a sixth grade reading level; SHALOM Denver uses OED-approved materials (instructions for a targeted resume, cover letter, and 30-second commercial, among others)

The 1,005 participants that SHALOM Denver will serve in this contract year are estimated to include 14 carry-in, 913 new enrollments, and 78 follow-up and retention clients.
