

**NINTH AMENDMENT TO  
AGREEMENT FOR SERVICES  
SHL US, LLC**

This **NINTH AMENDMENT** to agreement for services with SHL US, LLC (“**Ninth Amendment**”) is entered into by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the “**City**”) and SHL US, LLC, a Delaware limited liability company, with its principal place of business located at 111 Washington Avenue South, Suite 500 Minneapolis, Minnesota 55401 (“**Consultant**”), jointly “the parties”.

**RECITALS**

**WHEREAS**, the Parties entered into that certain services Agreement dated September 24, 2015 (“**Agreement**”), contract #CSAHR-201523127-00, and;

**WHEREAS**, the Parties, in writing, amended the Agreement (“**First Amendment**”), contract #CSAHR-201523127-01, dated November 20, 2015, and;

**WHEREAS**, the Parties, in writing, amended the Agreement and First Amendment (“**Second Amendment**”), contract #CSAHR-201523127-02, dated February 24, 2016, and;

**WHEREAS**, the Parties, in writing, amended the Agreement and all prior amendments (“**Third Amendment**”), contract #CSAHR-201523127-03, dated September 28, 2016, and;

**WHEREAS**, the Parties, in writing, amended the Agreement and all prior amendments (“**Fourth Amendment**”), contract #CSAHR-201523127-05, dated December 14, 2016, and;

**WHEREAS**, the Parties, in writing, amended the Agreement and all prior amendments (“**Fifth Amendment**”), contract #CSAHR-201523127-06, dated March 10, 2017, and;

**WHEREAS**, the Parties, in writing, amended the Agreement and all prior amendments (“**Sixth Amendment**”), contract #CSAHR-201523127-07, dated May 26, 2017, and;

**WHEREAS**, the Parties, in writing, amended the Agreement and all prior amendments (“**Seventh Amendment**”), contract #CSAHR-201523127-08, dated March 02, 2018, and;

**WHEREAS**, the Parties, in writing, amended the Agreement and all prior amendments (“**Eighth Amendment**”), contract #CSAHR-201523127-09, dated March 28, 2019, and;

**WHEREAS**, the City’s contract software that assigned the contract number to this Agreement has changed from Alfresco to Jaggaer. Under the new Jaggaer system, this Ninth Amendment is assigned the following new contract number: CSAHR-202055766-10;

**WHEREAS**, the Parties desire to amend the Agreement to extend the term and increase the Maximum Contract Amount as follows:

**AGREEMENT**

**NOW, THEREFORE**, in consideration of the premises, the mutual agreements herein contained, and subject to the terms and conditions hereinafter stated, the Parties agree to amend the Agreement as follows:

1. Paragraph 3 of the Agreement (entitled “**Term**”) is hereby amended to read as follows:  
“3. **TERM:** The Agreement will commence on October 1, 2015 and will expire at 11:59 p.m. on December 31, 2021 (the “**Term**”).”

2. Consultant hereby affirms, adopts and ratifies for all purposes, all duties and obligations under the Agreement and all amendments thereto.

Except as herein amended, the Agreement is affirmed and ratified by the Parties in each and every particular.
