WHEREAS, the City Council, pursuant to Proclamation No. 20-0350 passed on April 13, 2020, urged and supported a moratorium on rent because many people are unable to pay as a result of repercussions from the COVID-19 crisis ("Proclamation");

2020 003) dated March 11, 2020, as may be amended, on the same basis, and the President of the

United States issued a Declaration of Emergency on March 13, 2020, due to the COVID-19 crisis

WHEREAS, the City has entered into seven (7) commercial leases, licenses and concession agreements ("Leases") in which the City is the owner of the premises to lessees, licensees and concessionaires ("Tenants"):

WHEREAS, the City desires to give the Director of Real Estate ("Director") the authority to negotiate amended Leases with the City's Tenants; and

WHEREAS, in accordance with the Proclamation, City Council desires to give the City's Tenants relief from rent payments due to the City.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The Lease amendments may modify payment of rent for a period of up to three months, in addition to monthly payments modified in Ordinances No. 20-0388 and No. 20-0665, Series of 2020, for a total of nine months, to allow Tenants relief from the COVID-19 crisis, as long as such Tenants are and remain current on all other terms of the Lease, agree to extend the Lease for the number of months for which rent is delayed, rescheduled, modified or deferred.
