## Executive Summary

The Archdiocese of Denver own a residential facility at 3629 W. 29<sup>th</sup> Avenue which has approximately 75 small apartment like units. The intent is to shelter migrant families. City will be responsible for utilities, maintenance and repairs. To offset rent, the City and the Archdiocese will exchange parcels of similar size and value that each leases from the other and has for more than 25 years. It is the difference between the value of the City's parcel and the lesser value of the Archdiocese's parcel that offsets the rent. Service provider is Catholic Charities.

### Exchange Parcels:

- City owned land – 3546 Kalamath Street and 1120 W. 36<sup>th</sup> Avenue
  - Approximately .46 acres
  - near lady of Guadalupe church
  - Leased for a parking lot; City has leased to Archdiocese since early 1990s; Archdiocese invested in all improvements; lease had a purchase option
- Archdiocese owned land – 2900 W. Harvard Avenue
  - Approximately .51 acres
  - 2900 W Harvard Ave near All Saints church
  - Leased for Harvard Gulch West ballpark; Archdiocese has leased to City since early 1990s.
