## BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER;

**Section 1**. That the proposed Globeville Neighborhood Plan, consisting of a document of the same named filed with the City Clerk, Ex-Officio Clerk of the City and County of Denver, on the 20<sup>th</sup> day of November, 2014, as City Clerk Filing No. 2014-0942 (the "2014 Globeville Neighborhood Plan"), is hereby accepted and adopted as part of the Comprehensive Plan, pursuant to Section 12-61 of the DRMC.

- **Section 2**. That the 2014 Globeville Neighborhood Plan replaces and supersedes the 1989 Globeville Neighborhood Plan in its entirety.
- **Section 3**. That the 2014 Globeville Neighborhood Plan replaces and supersedes the River North Plan in its entirety with respect to only the Globeville neighborhood.

**Section 4**. That this acceptance of the 2014 Globeville Neighborhood Plan, and of any amendment thereto, is intended to establish the same, in conjunction with the Comprehensive Plan, as the official guide for officials of the City and County of Denver and private citizens when making decisions affecting the future of the Globeville neighborhood, as defined in said plan; provided however, that such approval shall not preempt the decision making powers vested by law or administrative directive in the Mayor, the Council or any other official of the City and County of Denver with respect to, but not limited to: a zoning map amendment, a zoning language amendment, a dedication or vacation of a street, alley or other public way, a designation of a park, the issuance of a revocable permit, a conveyance or acquisition of real property by the City and County of Denver, or an appropriation for or construction of a capital improvement; and provided, further that it is expressly understood that judgment must be exercised in the application of the 2014 Globeville Neighborhood Plan in the decision making processes of the Mayor, Council and other officials of the City and County of Denver.
