**A BILL**

**For an ordinance making a supplemental appropriation from the General Contingency Fund to the Department of Environmental Health.**

**WHEREAS**, the Department of Environmental Health needs budget adjustments due to adding positions, increasing supplies and adding hours for the Denver Animal Shelter and for sick and vacation payouts;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:
