- 5. Describe the proposed ordinance, including what the proposed ordinance is intended to accomplish, who's involved
 - a. Scope of Work

The Denver Botanic Gardens serves as a local, regional and national cultural, tourist and educational institution. This ordinance is in compliance with the cooperative agreement with the Denver Botanic Gardens to run this botanical facility.

Denver Botanic Gardens is now a true year round attraction with the completion of the Bonfils-Stanton Visitor Center and parking structure, and the summer completion of the Mordecai Children's Garden and the new Green House Complex, Orangery and Marnie's Pavilion.

Currently, the admission fees at the Gardens have a May through September rate and a lower October through April. The proposed year round rate will raise the off season rate by \$1.00 to be the same as the current May through September rate. The Gardens propose establishing rates for new facility rental spaces as well as updating certain facility rentals fees based on market rate comparisons. (please see attachment) The proposed fees are comparable with general admission fees for other Denver cultural attractions. The DBG remains committed to make the gardens accessible to everyone. Fees will be Effective October 10, 2010.
