In 2013, through a RFP, Transcore ITS, LLC was awarded a contract to provide the software applications and continued Operations & Maintenance for an Advanced Traffic Maintenance System (ATMS).

This amendment will add funds and term for Transcore ITS, LLC to continue to provide operations and maintenance support through year 2027 for the Traffic Control System (monitoring and control of traffic signals) and Traffic Management System (collects and stores data from traffic devices).

NOTE: Procurement for the Central Server System is currently in progress, with award anticipated late 2026. Amending this contract with Transcore ITS, LLC through 12/31/27 will ensure uninterrupted operations and support during the transition period, including system integration, testing, and overlap with the new vendor.
