It's a privilege to work with so many of you in mobility policy through my work at AAA, at local transportation management associations, on the DRCOG regional transportation committee, and at other shared community touchpoints. I'm reaching out in my personal capacity as a Denver resident, property owner, and taxpayer.

I am writing to express my support for the zoning amendment under Ordinance 24-0732. The zoning change contemplated here would create more affordable, accessible housing along a major transit corridor with easy access to the Colorado

Blvd. BRT study area and existing RTD rail routes.

In a general sense, this exact type of development is the sort of thing Denver aspires to in its transportation policy: thoughtful, affordable, reasonable density in an area, well-served by transit, such that residents won't necessarily need to own a personal automobile. With regard to this project, specifically, I can't think of a population more deserving of mobility freedom than seniors who may not be able to afford the skyrocketing cost of automobile ownership - and who may experience difficulties in automotive mobility given the cognitive and visual-motor effects of aging on safe driving. Everybody deserves to live with dignity, which those of us transportation policy define to mean affordable housing *and* straightforward access to different mobility options, as there is little dignity in feeling trapped at home. This project achieves those twin goals, especially given the proposed co-location of a trusted community partner such as The Center on Colfax on site.

Dignity, equity, and freedom: Three core components of making a place feel like home. This rezoning will help Denver accomplish all three for the residents it serves. I urge a yes vote on Ordinance 24-0732.
