

FOURTH AMENDATORY AGREEMENT

THIS FOURTH AMENDATORY AGREEMENT, is made and entered into this _____ day of _____, 2010, by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation organized pursuant to the Constitution of the State of Colorado (the "City"), and **URS CORPORATION**, a Nevada corporation, (the "Design Consultant"), whose address is 8181 E. Tufts Avenue, Denver, Colorado 80237.

WITNESSETH

WHEREAS, the City and the Design Consultant entered into an Agreement dated January 8, 2008, (the Agreement"), an Amendatory Agreement dated March 18, 2008, a Second Amendatory Agreement dated October 6, 2009, and a Third Amendatory Agreement dated March 30, 2010;

WHEREAS, the City and the Design Consultant desire to amend the Agreement to extend the term;

NOW THEREFORE, in consideration of the premises, and the mutual covenants and obligations herein contained, the parties agree as follows:

1. Subsection 1 of Paragraph D of Article VIII of the Agreement, entitled "**Term and Termination**" is hereby amended to read as follows:

"1. "The Term of the Agreement shall commence on October 1, 2007 and shall end on June 30, 2011. However, nothing contained herein shall preclude the Consultant from completing any task authorized prior to the expiration of this Agreement and the Agreement shall be extended until the completion of and payment for all such authorized tasks."

2. As herein amended, the Agreement is affirmed and ratified in each and every particular.
