4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system a parcel**  
6 **of land as a public alley bounded by South Acoma Street, West Arkansas**  
7 **Avenue, South Broadway, and West Louisiana Avenue.**

8 **WHEREAS**, the Executive Director of the Department of Transportation and Infrastructure of  
9 the City and County of Denver has found and determined that the public use, convenience and  
10 necessity require the laying out, opening and establishing as a public alley designated as part of the  
11 system of thoroughfares of the municipality that portion of real property hereinafter more particularly  
12 described, and, subject to approval by resolution has laid out, opened and established the same as  
13 a public alley;

14 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

15 **Section 1.** That the action of the Executive Director of the Department of Transportation  
16 and Infrastructure in laying out, opening and establishing as part of the system of thoroughfares of  
17 the municipality the following described portion of real property situate, lying and being in the City  
18 and County of Denver, State of Colorado, to wit:

20 **LAND DESCRIPTION - ALLEY PARCEL**

21 A PARCEL OF LAND CONVEYED BY SPECIAL WARRANTY DEED TO THE CITY AND  
22 COUNTY OF DENVER, RECORDED ON THE 12TH DAY OF APRIL, 2023, AT RECEPTION  
23 NUMBER 2023033529 IN THE CITY AND COUNTY OF DENVER CLERK AND RECORDER'S  
24 OFFICE, STATE OF COLORADO, THEREIN AS:

26 THE EAST 2.0 FEET OF LOTS 23 AND 24, BLOCK 2, OVERLAND PARK SUB-DIVISION, CITY  
27 AND COUNTY OF DENVER, STATE OF COLORADO.

29 THE ABOVE DESCRIBED PARCEL CONTAINS 100 SQUARE FEET OR 0.0023 ACRES MORE  
30 OR LESS.

32 BASIS OF BEARINGS: AN ASSUMED BEARING OF N00°06'15"E BEING A 10 FOOT RANGE  
33 LINE LOCATED IN SOUTH ACOMA STREET BETWEEN TWO FOUND MONUMENTS 685.34  
34 FEET APART; ONE MONUMENT BEING AN AXLE IN A SURVEY RANGE BOX AT THE  
35 INTERSECTION OF SOUTH ACOMA STREET AND WEST ARKANSAS AVENUE AND THE  
36 OTHER MONUMENT BEING A BROKEN STONE IN A SURVEY RANGE BOX AT THE  
37 INTERSECTION OF SOUTH ACOMA STREET AND WEST LOUISIANA AVENUE

2 declared laid out, opened and established as a public alley.
