A BILL

For an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the United States Department of Labor concerning the "Youth Ex-Offenders" program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement, under CFDA No. 17.270, between the United States of America and the City and County of Denver, which is identified as Grant Number PE-23374-12-60-A-8, a copy of which is duly filed with the City Clerk, Filing No. 12-0656, be and hereby is approved in all respects.

Section 2. The payments made by the United States of America to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 17000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said "Youth Ex-Offenders" Program, Accounting No. 17100-0117101-M1096 is as follows, to be expended by the Director of the Office of Economic Development:

Authorization for expenditure of said funds following execution of said grant will cover the period from July 1, 2012 to December 31, 2014.
