A BILL

For an ordinance authorizing expenditures in the Human Services Special Revenue Fund based on award of allocation letter of intent from the State of Colorado to award funding for the "Community Services Block Grant FY14-15" program.

WHEREAS, the State of Colorado awards Community Service Block Grant (CSBG) funds to the City and County of Denver annually; and

WHEREAS, the Colorado Department of Local Affairs has sent a letter stating their intent to provide CSBG FY14-15 funds to the Denver Department of Human Services; and

WHEREAS, the City and County of Denver has given due consideration to said letter of intent to fund, a copy of which is duly filed with the City Clerk, Filing No. 14-0316;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Expenditures are hereby authorized from the Human Services Special Revenue Fund, Accounting No. 13000, the amounts of money in the following tabulation to be expended for the purposes and upon the authorizations in said Ordinance set forth:
