Amend Award to Catholic Charities and Community Services of the Archdiocese of Denver a delegate agency contract in the amount of \$1,280,683.00 to provide comprehensive Head Start services to 195 children, ages 3 to 5 years old for the period July 1, 2019 thru June 30, 2020.

This year, the Federal Office of Head Start allowed the city to combine the base grant and the cost of living adjustment into one application. This process is typically done separately and requires amendments to each contract for any adjusted award amounts. However, because of this adjusted process, there was an error in calculating the award for each delegate grant application. Therefore, a small adjustment to the contract amount is necessary to ensure the delegate agencies receive their full funding.
