4 A RESOLUTION

To set a public hearing relating to the approval of the Tamarac Square South Urban Redevelopment Plan.

WHEREAS, City Council desires to set a public hearing on the adoption of the Tamarac Square South Urban Redevelopment Plan pursuant to C.R.S. § 31-25-107(3);

NOW, THEREFORE,

BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Date, Time and Location of the Tamarac Square South Urban Redevelopment Plan Public Hearing. The City Council shall conduct a public hearing on the Tamarac Square South Urban Redevelopment Plan. The Tamarac Square South Urban Redevelopment Plan covers a portion of the former Tamarac Square shopping center site generally located at Hampden Ave. and Yosemite St. The Urban Redevelopment Project is the redevelopment of a portion of the former Tamarac Square shopping center site by the construction of a Target retail store, site improvements, right-of-way improvements and other public and life safety improvements at that site. The public hearing shall be on Tuesday, March 27, 2012, at 5:30 p.m. in Council Chambers in the City and County Building located at 1437 Bannock Street, in Denver, Colorado.

- **Section 2**. Other Notices. The Denver Urban Renewal Authority is requested to give all written notices and publications required by C.R.S. § 31-25-107, including the notice requirements set forth in C.R.S. § 31-25-107(3)(a).
- **Section 3**. Plan Submittal. C.R.S. § 31-25-107(3.5) requires the Denver Urban Renewal Authority to submit the Tamarac Square South Urban Redevelopment Plan to the City Council and Board of Equalization of the City, sitting as the Board of County Commissioners in accordance with the Charter of the City at least 30 days prior to the public hearing. The Denver Urban Renewal Authority is hereby directed to submit the Tamarac Square South Urban Redevelopment Plan to the City Council and the Board of Equalization and have a copy filed with the Denver City Clerk for public use no later than February 24, 2012.
- **Section 4**. The Clerk of the City and County of Denver shall attest and affix the seal of the City and County of Denver to this Resolution.
