**A BILL**

**For an ordinance making rescissions from the General Fund, the Capital Improvement Fund, and the Economic Opportunity Special Revenue Fund, to make appropriations and cash transfers in the General Fund and the Capital Improvement Fund, and appropriations in the General Government Special Revenue Fund to support the Border Crisis Special Revenue Fund for costs related to support for asylum seekers.**

**WHEREAS**, the City desires to reallocate personnel savings and services and supplies budget from the Agency General Fund appropriations and inactive Innovation Fund technology projects to the Denver Human Services Border Crisis Response Special Revenue Fund (SRF); and

**WHEREAS**, the City desires to generate savings in Agency General Fund appropriations for the Border Crisis Response SRF by reallocating appropriate expenditures from the General Fund to the Internal Billings and Reimbursements SRF, which requires increasing the appropriation in that SRF; and

**WHEREAS**, said reallocations will support personnel and services and supplies costs related to support for asylum seekers coming into Denver from outside of the US border;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund and the Capital Improvements and Capital Maintenance Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":

 10 11000, from cash balances not otherwise appropriated and in addition to amounts heretofore  
 11 appropriated by Ordinance No. 1682, Series of 2023, and any supplemental appropriations or  
 12 rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the  
 13 amount of money following such designation, to be expended for the purposes and upon the  
 14 authorizations in said Ordinance set forth:
