**A BILL**

**For an ordinance making a rescission from the General Fund Public Works appropriation and making an appropriation in and a cash transfer to the Capital Improvements and Capital Maintenance Fund.**

**WHEREAS**, City Council is requesting budget for a speed safety study; and

**WHEREAS**, the Department of Public Works is projecting year-end savings in 2019 and the budget for a portion of said savings can be rescinded and re-appropriated to support a speed safety study;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:

**Section 2.** From the General Fund, Accounting No. 01010, out of monies rescinded from Section 1 not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1280, Series of 2018, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:

4 transferred in Section 2 and not otherwise appropriated and in addition to amounts heretofore  
5 appropriated by Ordinance No. 1280, Series of 2018, and any supplemental appropriations or  
6 rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the  
7 amount of money, following such designation, to be expended for the purposes and upon the  
8 authorizations in said Ordinance set forth:



