6 **For an ordinance approving the purchase of capital equipment items from the**  
7 **Planned Fleet Special Revenue Fund.**

9 **WHEREAS**, the Solid Waste Division in Public Works is requesting to purchase five side  
10 loaders to bring the ratio of trash trucks to personnel closer to the minimum industry standards of  
11 15% to 20%;
