4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system parcels of**
6 **land as East Colfax Avenue and a public alley located at or near the intersection**
7 **of East Colfax Avenue and North Xanthia Street.**

8 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has
9 found and determined that the public use, convenience and necessity require the laying out, opening
10 and establishing as a public street and as an alley designated as part of the system of thoroughfares
11 of the municipality those portions of real property hereinafter more particularly described, and,
12 subject to approval by resolution has laid out, opened and established the same as a public street
13 and as a public alley;

14 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

15 **Section 1.** That the action of the Executive Director of Public Works in laying out, opening
16 and establishing as part of the system of thoroughfares of the municipality the following described
17 portions of real property situate, lying and being in the City and County of Denver, State of Colorado,
18 to wit:

19 **PARCEL DESCRIPTION ROW NO. 2018-DEDICATION-0000177-001:**

20 The South 7.00 feet of that property described in Reception Number 2017140201, recorded
21 October 25, 2017 at the City and County of Denver Clerk and Recorder’s Office, situated in the SE
22 1/4 of Section 33, T.3S., R.67W., of the 6th P.M., City and County of Denver, State of Colorado,
23 and being more particularly described as follows:

24 **LAND DESCRIPTION-STREET PARCEL#1**

25 Beginning at the Southeast Corner of Lot 29, Block 6, East Colfax Subdivision;
26 Thence N90°00’00”W along the North R.O.W. Line of East Colfax Avenue, a distance of 150.50
27 feet to the West Line of the East 6 inches of Lot 23, said Block 6;
28 Thence N00°01’30”W along said West Line of the East 6 inches of Lot 23, a distance of 7.00 feet;
29 Thence N90°00’00”E a distance of 150.50 feet to a point on the West R.O.W. Line of Xanthia
30 Street;
31 Thence S00°01’30”E along said West R.O.W. Line, a distance of 7.00 feet to the Point of

13 and being more particularly described as follows:
